

Abstract:

This paper empirically shows that at least some of the costs of curbside parking spaces are capitalized in housing prices even though these parking spaces are not formally bundled with housing units. Making use of Istanbul's transition from free and informal curbside parking to paid and formal, we find that housing prices decreased substantially as a response to the city operating curbside parking, while rents remained statistically the same or at best decreased only very slightly.
